

WHAT TYPES OF ITEMS ARE IN THE PLAN?

- Safety Projects school office renovations, security and surveillance systems, school intercom systems, playgrounds and shade structures
- Technology infrastructure such as cabling, servers and switches, classroom interactive technology, video distribution, classroom computers
- Building system upgrades and replacements HVAC, roofing, flooring, sound and presentation systems, stage curtains and lighting
- Site upgrades concrete and asphalt upgrades
- New construction includes replacing portable buildings with permanent buildings, rebuild one school
- Pupil transportation replace aging buses



EXAMPLES OF HOW MANY SCHOOLS WILL BE IMPACTED BY NEW BOND DOLLARS

- Sound and presentation systems 20 sites
- Intercom systems 20 sites
- Technology
 - Most sites will receive infrastructure equipment approximately \$10 million reserved for these types of items
 - Classroom computers and technology still to be determined approximately \$9 million reserved for these types of items.



EXAMPLES OF HOW MANY SCHOOLS WILL BE IMPACTED BY NEW BOND DOLLARS

- Flooring replacement 19 sites
- Energy management systems for HVAC 10 sites
- Playgrounds and shade structures 18 sites
- Stage curtains and lighting 30 sites
- New construction 6 schools
- Office renovations 6 schools



WHAT IS THE ESTIMATED TAX RATE IMPACT?

Current year tax rate		\$1.47
Estimated tax rate 2017-2018 (first year of bond proceeds)	\$0.43	\$1.36
Estimated average tax rate (over life of bond authorization)	\$0.77	



HOW DO WE DETERMINE PRIORITY OF NEEDS?

- Whether it affects student safety or code compliance
- Age and condition of building systems and or equipment
- Periodic review of building systems to evaluate condition and need
- Ability to maintain equipment internally, or parts availability
- Record all site and building improvements and replacement of building and infrastructure equipment as completed to ensure all asset information is up to date.
- Site or building improvement requests submitted by schools and departments are monitored frequently to determine whether budget must be allocated immediately, project can be completed with internal staff, or project can be incorporated into future projects at that site.
- Continuous improvement plans for the district need to ensure resources and equipment are available to move forward with the strategic plan.

- Evaluated and reprioritized site improvement requests from schools and departments in relation to changes that have occurred at these sites.

- Rescheduled some projects that will be delayed due to lack of funding availability in recent years.
