# **Resources for Families**

We know that many of our families are struggling during these challenging times. The Web site, **arizonatogether.org**, provides many resources for families including mental health, employment, financial assistance, community resources and options for Internet access, to name a few.

The Web site, **211arizona.org** also provides resources for families including clothing, housing, health and dental, support groups and family services. The WESD Social Services Department, including school social workers, are available remotely through email, available on school Web sites, and will be checking voicemail regularly if you need assistance.

#### **Grab and Go Meal Program Change**

Since the Grab and Go program began March 23, we have provided more than 101,325 meals to our WESD community. We know that many rely on this service and we enjoy seeing students and families daily. However, for the health and safety of our families and Nutrition Services staff, the Grab and Go program will be available once a week. Students will continue to receive five breakfasts and five lunches. There will be no food distribution on Monday, April 13. Beginning Tuesday, April 14, meals will be provided every Tuesday from 10:00 a.m. to noon at the 13 locations listed below.

- Starting Tuesday, April 14, meals will be distributed every **Tuesday**. Students will be provided with five (5) breakfasts and (5) lunches at this time.
- The offerings will be served in larger portions (for example, milk will be in gallons) and will include items that need to be refrigerated and frozen items that can be reheated.
- Food bags will have enough food for the number of children in each family.
- The items will be delivered in large grocery bags.
- Families who drive through the pickup line should have their trunks open and cleared out so they can place the bags inside.
- Families who walk are encouraged to bring a wagon or cart.

## **Chromebook Pickup**

Last week, we began providing grade-level packets online and offered an opportunity for paper packet pick up. Additionally, students have been meeting with their teachers using Google Meet either online or by calling in. We know that participating in these opportunities has been challenging for families who do not have a device or access to Internet. To help with devices, we will distribute one Chromebook to families with students in kindergarten through eighth grade who do not have one at home.

Chromebooks will be available to borrow for the duration of the school year. Due to a limited number of devices and, to provide devices for more households, **each family will be limited to one device**. **In order to use the device, families must have Internet access.** There are several Internet providers offering low cost packages. Options are listed below.

## Chromebook distribution will take place Wednesday, April 15.

- Families with more than one child, should pick up a device at the school where their OLDEST child is enrolled.
- The device must be picked up by the parent or legal guardian.

- The parent/legal guardian must present an ID and contact information will be verified.
- Please bring a pen or pencil to write with.
- The parent/legal guardian will sign an agreement prior to receiving the device.
- If possible, bring your child's student ID.
- The device is on loan and will be required to be returned at a later date.

To ensure the health and safety of all, families will be asked to remain in their car or keep a safe distance of six feet if walking to pick up (CDC guidelines). Please anticipate some wait time.
