While Tuesday, May 19 is the last day of school, please know that we are planning for the next school year, which starts Monday, August 10. We will be using guidance from the CDC (Center for Disease Control), the Arizona Department of Health Services, the Governor's Office, and the ADE (Arizona Department of Education). Grab and Go Meal Program – Ends Tuesday, May 19. Summer Feeding Begins Monday, June 1

During the last eight weeks, the WESD served 533,500 meals! The last day of the Grab and Go program is Tuesday, May 19 from 9:00 to 11:00 a.m. at the 13 locations below. There will be no meal service May 25-29. The Glendale Union High School District will be providing meals the week of May 25-29 for families who need it. The Nutrition Services Department begins its Summer Feeding program Monday, June 1. Specific information about times and locations will be sent next week.

## Chromebook Return - Monday, May 18

If you checked out a Chromebook for your student, it needs to be returned to the school that you checked it out from on Monday, May 18. #### Student Belongings Pickup – Monday, May 18

This week, teachers returned to their classrooms and removed students' personal belongings from their desks. These items will be bagged and labeled and the teacher will reach out directly to students who have items to be picked up. ### Medication Pickup – Appointment only, Tuesday and Wednesday, May 19 and 20

School Health Techs will be calling families who have medication in the Health Office and scheduling a time on either Tuesday, May 19 or Wednesday, May 20 to pick it up.

The priority during this time has been the health and safety of our students and staff. Our goal has been to provide meaningful educational opportunities that reinforce standards by providing weekly packets and online options.

WESD will focus on diagnosing the needs of each child when school opens. Interventions and small group instructional strategies will be prioritized upon return to school to close any gaps in student learning due to the closure.

The State Board of Education took action on March 31, 2020, to enact an emergency regulation that changed the requirements of a minimum course of study. Local school districts may determine if a student met or was on track to meet the minimum course of study and competency requirements prior to the school closure. Based on this guidance, the WESD will use the letter grades from quarters one, two and three (for grades  $3^{rd} - 8^{th}$  grade) and mastery of standards from quarters one, two and three (for grades  $K-2^{nd}$ ) to promote students this year. Therefore, the report card that was sent home at the end of third quarter reflects your child's progress for the 2019-2020 school year. No report card will be sent home for the fourth quarter.

#### **Retention/Promotion**

Unless you have received communication throughout the year that retention was being considered, your child will be promoted to the next grade for the 20-21 school year. If your child's teacher has discussed retention with you throughout the year, you will be contacted by the school no later than May 18, 2020, as to a final decision.

### Office Hours for the Administrative Center and Schools Starting Monday, May 18

With the Governor's Stay Home order expiring today, the WESD is moving into Phase 1 of reopening. This means the District will continue to follow the CDC Guidelines related to social distancing, reinforcing hygiene and cleaning practices and limiting the number of people in buildings. Limited staff will be working in their locations beginning Monday, May 18. Main phone numbers will be answered during regular business hours. To visit a school or the Administrative Center, you will need to make an appointment with the person you want to meet with in advance.

Please stay safe and care for the needs of your family. WESD continues to remain committed to offering resources and support during these challenging times.
